

Alabama JAG PERMISSION/PARTICIPANT FORM (3 PAGES TOTAL)

CODE OF CONDUCT

The following conduct policies will apply to all delegates: students, specialists, and any other authorized persons attending the conference. This form must be signed by each student attending Alabama JAG State Career Development Conference and submitted to the JAG specialist prior to the conference. The JAG specialist must have a completed copy of the permission/participant form for each student attending in their possession for the duration of the event, including travel to and from the event. This form must be kept on file in the local school district after the conference.

Delegates shall abide by the rules and practices of Alabama JAG and school district policies at all times to, during, and from the designated point of origin of the conference. Delegates shall respect and abide by the authority vested in the Alabama State Department of Education/Alabama CTE Leadership Council.

The standards outlined in this document constitute the Alabama JAG Code of Conduct. The following shall be regarded as severe violations of the Alabama JAG Code of Conduct: Should a conduct code violation occur for item 1 through 6 below, regardless of when exposed, the violating student(s) will be sent home. If the violation warrants it, law enforcement may also be notified. Determination of penalties for violations will be at the discretion of the Alabama JAG Staff.

- 1. **Alcohol, Drugs and Tobacco**: a student shall not possess, use, transmit, be under the influence of, or show evidence of having used an alcoholic beverage, other drugs, substances or tobacco products capable of or intended, purported, or presumed to be capable of altering a student's mood, perception, behavior or judgment; other than properly used, over-the-counter pain relievers and medications prescribed by a physician for an individual student and must be on record with the specialist. Nor shall the student possess, use, sell or transmit paraphernalia associated with drugs, alcohol, or chemical substance in any form (including tobacco), at any time, or under any circumstances, on public or private properties.
- 2. Curfew: Committing serious violations of curfew regulations as outlined in item 8 below.
- **3. Willful Companionship**: Being in the willful companionship of someone who violates any portion of the conduct code or failing to report any direct knowledge (other than hearsay) of the conduct code violations.
- 4. **Personal Conduct:** Cheating, dishonesty, or taking unfair advantage of others; participating in social activities other than those with conference participants; conducting acts and/or possession of weapons capable of causing bodily harm or fear of life, defacing or stealing any public or private property (for which financial responsibility will rest solely with offending individuals or their program); breaking the law; other serious violations of personal conduct regulations.
- 5. **Serious Violations** of the student conduct code of the school district or school that the student represents.
- 6. **Abusive Behavior and Lewd** Conduct: A student shall not engage in any lewd, indecent, sexual, or obscene act or expression or possess such materials. A student shall not engage in verbal, physical or sexual harassment, hazing, or name-calling. The use of slurs against any person on the basis of race, color, creed, national origin, ancestry, age, sex, sexual orientation, or disability is prohibited.



The following shall be other violations of the Alabama JAG Code of Conduct: Should a conduct code violation occur for items 7-11 below, regardless of when exposed, the violating student(s) may be sent home. Determination of penalties for violations will be at the discretion of the Alabama JAG Staff or local JAG Specialist.

- 7. **Conference Conduct**: Leaving sessions prior to their conclusion is prohibited (except in the case of emergency); failing to attend all general sessions and assigned activities for which a delegate is registered; not abiding by the rules and regulations of JAG or school/district policies from the time he/she leaves his/her home or school for any activity and the time he/she returns to the same home or school following the conference.
- 8. **Curfew** (when applicable): Failing to be in your assigned hotel room from the curfew time designated in the conference program until 6 a.m.; causing any noise or other disturbance audible by anyone in the hallway after designated curfew time; ordering any food after the designated curfew time; causing any other unnecessary disturbance or participating in any other inappropriate activity after the designated curfew time.
- 9. **Dress:** Failing to abide by the dress regulations established for the conference, as outlined in the Dress Code.
- 10. **Personal Conduct**: Failing to report accidents, injuries or illnesses immediately to the local JAG Specialist; failing to keep adult JAG specialists informed of activities and whereabouts at all times; using tobacco products outside of local school district policies and state law; having a member of the opposite sex in a room if no adult chaperone is present and the room door is not visibly open (e.g. the door may be propped wide open); having a delegate or JAG specialist of the opposite sex in a room without a third person present and the door visibly open.
- 11. Hotel Conduct: Failing to meet the professional standards of housing facilities; accruing incidental room charges (i.e., phone calls, room service, pay-per-view movies, etc.) without settling the account prior to checkout; throwing objects out the window or into the hallway; moving hotel furniture from rooms (e.g., onto the balcony); failing to follow hotel rules and regulations.

Individual School District Policies may supersede the code of conduct.

DRESS CODE FOR DELEGATES ATTENDING ALABAMA JAG

The following guidelines have been developed to clarify the dress code used at JAG.

- Professional Dress: JAG official dress or suit/blazer with collared shirt (tie is optional), slacks/skirt (appropriate length), and appropriate shoes. Competitors to be in Professional Dress.
- Business Casual Dress: Collared shirt with slacks/skirt and appropriate shoes or dress blouse with slacks/ skirt (appropriate length) and appropriate shoes. Leadership track students may select Professional Dress or Business Casual Dress.
- Inappropriate Dress: Tank tops, mid-riff tops, T-shirt with suggestive words or pictures, denim pants or skirts, mini-skirts, shorts, overalls, tennis shoes, sandals, and/or mules.
